The Antenna Company is committed to protecting the privacy of your personal data. This Private Notice describes how The Antenna Company may use, maintain, protect, or transfer certain types of personal information obtained through the use of our websites, mobile applications and our products and services.

PRIVACY POLICY GOVERNING ALL WEBSITES AND MOBILE APPLICATIONS MAINTAINED BY THE ANTENNA COMPANY INTERNATIONAL N.V. ("COMPANY")

1. **Information Collected.** To the extent deemed necessary or desirable by Company for the efficient provision of the products, services and opportunities contemplated hereby and in the related Terms of Service, you provide us in various ways, directly and indirectly through our website and through the websites of third parties with whom we engage to provide our services and we collect, analyze and utilize for provision of goods and performance of our services from time to time, various information from our customers, and other parties relevant to our efforts.
